

**L AFC AWAY DAYS PRESENTED BY DELTA AIR LINES
SWEEPSTAKES OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT
INCREASE YOUR CHANCES OF WINNING.**

ELIGIBILITY: L AFC Away Days presented by Delta Air Lines Sweepstakes (the “Sweepstakes”) is open to legal residents who live within a seventy-five (75) mile radius from Los Angeles, CA (the “Territory”) who are of legal age of majority in the jurisdiction in which they reside (and at least 18 years old) at the time of entry. Employees, officers, and directors (including immediate family members (spouse, parent, child and sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of L AFC Sports, LLC (“Club”), Delta Air Lines (together with the Club, the “Sponsor”), Major League Soccer, L.L.C. (“MLS”), and Soccer United Marketing, LLC (“SUM” and collectively with Sponsor and MLS, the “MLS Entities”) and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the Sweepstakes are not eligible to participate or win a prize. The Sweepstakes is subject to all applicable federal, state and local laws, rules and regulations. Void outside Territory, and where prohibited or restricted by law, rule or regulation.

HOW TO ENTER: The Sweepstakes begins at 12:00 AM Pacific Prevailing Time (“PPT”) on September 17, 2021 and ends at 11:59 PM PPT on October 15, 2021 (“Entry Period”). During the Entry Period, there are two (2) ways to enter. No other method(s) of entry will be accepted. Limit one (1) entry per person, per family, per e-mail address, social media handle or Twitter login, as applicable and per household, regardless of method of entry. Multiple entries received from any person or family or e-mail address or household in excess of the stated limitation will be void. Sponsor will not be responsible for incomplete, lost, late, misdirected or illegible entries, or for failure to receive entries due to transmission failures or technical failures of any kind, including, without limitation, malfunctioning of any network, hardware or software, whether originating with sender or Sponsor. In the event of a dispute, all electronic entries will be deemed to have been submitted by the owner of the electronic account from which they were sent. For these purposes, an electronic account holder shall mean the natural person assigned to such account by the Internet access provider, online service provider or other organization responsible for assigning electronic addresses for the domain associated with such electronic account. Sponsor reserves the right to disqualify any entries by persons determined to be tampering with or abusing any aspect of the Sweepstakes as solely determined by Sponsor. Sponsor’s clock shall be the official timekeeper of the Sweepstakes. In the event any aspect of the Sweepstakes is compromised by a virus, non-authorized human intervention, tampering or other causes beyond the reasonable control of Sponsor which corrupts or impairs the administration, security, fairness or proper operation of the Sweepstakes, Sponsor reserves the right in its sole discretion to suspend, modify or terminate the Sweepstakes. All information and files submitted in the format specified will become property of Sponsor and used as provided in the MLS Terms of Use and Privacy Policy, each of which can be found by visiting <http://www.mlssoccer.com/terms-service> and <http://www.mlssoccer.com/privacy-policy> (both of which are incorporated herein by reference).

1. Twitter: During the Entry Period, in order to enter the Sweepstakes through Twitter, you must (a) be a registered user of Twitter and (b) follow @L AFC. In order to participate in the Sweepstakes without receiving tweets on your mobile phone, be sure to deactivate your mobile phone from your Twitter account.

By submitting your completed entry via Twitter as directed, you will receive one (1) entry in the Sweepstakes.

This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with Twitter. You are providing your information to the Sponsor and not to Twitter.

2. Mail-in Method: During the Entry Period, you may enter the Sweepstakes by hand-printing your complete name, address, city, state and zip code, day and evening telephone number (including area code), date of birth and e-mail address (optional) on a 3"x5" postcard and mailing it in an envelope with proper postage affixed to: "L AFC Away Days presented by Delta Air Lines Sweepstakes," 818 W. 7th Street, #1200, Los Angeles, CA 90017. RANDOM DRAWING: The potential winner(s) of the Sweepstakes (each a "Winner" and collectively, the "Winners") will be selected by random drawing on or about October 25, 2021 from among all eligible entries received by the Sponsor. The decisions of Sponsor are final and binding on all matters relating to this Sweepstakes. Odds of winning depend on the total number of eligible entries received during the Entry Period.

PUBLICATION AND ASSIGNMENT OF RIGHTS TO SUBMISSIONS: By entering the Sweepstakes, each entrant agrees that his or her submission is an original work of authorship and he or she owns all right, title and interest in the entry as of the date of submission. Sponsor reserves the right to disqualify any entry it deems to be offensive, inappropriate, not in keeping with Sponsor's image or that is otherwise not in compliance with these Official Rules, in its sole discretion.

PRIZES: A Total of one (1) Grand Prize Is Available To Be Awarded ("Grand Prize").

The Winner will receive a trip for Winner and one (1) guest to Denver, Colorado ("Location") for the Colorado Rapids vs. LAFC match scheduled for November 7, 2021 (the "Game"). Grand Prize package includes round trip, coach-class air transportation for two (2) from a major airport near winner's home courtesy of Delta Air Lines (determined by Sponsor in its sole discretion and fulfilled with flight certificates) (Approximate Retail Value ("ARV"): \$1,000.00; two (2) nights' accommodations at Sponsor's choice of hotel (single room, double occupancy) (ARV: \$700.00); two (2) tickets to the Game (seat locations to be determined by Sponsor in its sole discretion) (ARV: \$300.00); and one (1) \$500 Visa gift card that may be used for ground transportation (terms and conditions apply). Travel must take place on the dates specified by Sponsor and surrounding the Game or winner will forfeit the prize. Winner and guest must travel together and on same itinerary. Travel must be round trip. Sponsor will determine airlines and flight itineraries in its sole discretion. No refund or compensation will be made in the event of the cancellation or delay of any flight.

Travel is subject to the terms and conditions set forth in these Official Rules, and those set forth by the Sponsor's airline carrier of choice as detailed in the passenger ticket contract. Any taxes, fees, or changes paid at the time of ticket issuance will be refunded if ticket is not used. However, once redeemed, Certificates are void and will have no further value. Travel will not qualify for SkyMiles mileage. Stopovers/Upgrades/Waitlisting/Open Returns are not permitted. Lost, stolen or otherwise destroyed Certificates will not be replaced.

Schedules are subject to change without notice. Additional restrictions may apply. It is the responsibility of the passenger to be in possession of all necessary documentation (e.g., valid passport, visa where applicable) at the time and place of departure. Delta reserves the right to deny boarding to any passengers without proper documentation. Sponsor and MLS Entities are not responsible if Game or any other scheduled event is delayed, postponed or cancelled for any reason and winner will not be reimbursed. Tickets may be subject to issuer's standard rain-check policies and procedures. If Winner's guest is a minor (as determined by his/her state of residence), winner must be minor's parent/legal guardian and must complete the required paperwork on behalf of minor, as applicable. Exact seat locations will be determined by Sponsor. The terms and conditions of the tickets awarded as prizes will govern in the event a game, event or exhibition, as defined by MLS, is not played due to weather, an Act of God, an act of terrorism, civil disturbance, work stoppage or any other reason. Winner and his/her guest(s) agree to comply with all applicable stadium regulations in connection with the Grand Prize. Sponsor and the applicable MLS Entities reserve the right to remove or deny entry to Winner and/or his/her guest(s) who engage(s) in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person at any game, event or exhibition. Released Parties (as defined below) will not be responsible for weather, Acts of God, acts of terrorism, civil disturbances, work stoppage or any other event that may cause the cancellation or postponement of any MLS game, event or exhibition.

A Total of Three (3) Additional Prizes Are Available To Be Awarded (each an "Additional Prize"). Each Additional Prize Winner will receive one (1) LAFC adidas authentic custom jersey (ARV: \$164.99). MLS Entities are not responsible for any loss or damage to prizes. The Additional Prizes consist only of the items described above. Actual value of the prize may vary. Any difference between the stated ARV and actual value will not be awarded. Winner is fully responsible for any and all applicable federal, state, and local taxes (including income and withholding taxes). All costs and expenses associated with Additional Prize acceptance and use not specified herein, including but not limited to any incidental expenses related to any transportation costs, meals, gratuities and other expenses incurred by accepting the Additional

Prize are the sole responsibility of the Winner. All Additional Prize details are at the MLS Entities sole discretion. Total ARV of all Additional Prizes: \$494.97. Each Additional Prize is non-transferable and non-assignable, with no cash redemptions or substitutions except at Sponsor's sole and absolute discretion. Sponsor reserves the right to substitute each Additional Prize (or portion thereof) with one of comparable or greater value, at its sole and absolute discretion.

Total ARV of all prizes: \$2,994.97

NOTIFICATION: Each Winner will be notified by e-mail, mail and/or telephone (in the sole discretion of Sponsor and/or the applicable MLS Entity, as applicable) by the Sponsor. In the event that any Winner does not respond to any such notification within three (3) days of the date of issuance, a disqualification will result, the Prize will be forfeited and, at Sponsor's sole discretion and time permitting, an alternate Winner may be chosen from among all remaining eligible entries. Each Winner may be required to submit his/her valid social security number (if applicable) and/or other identification to Sponsor and will be required to execute, have notarized and return an Affidavit of Eligibility and Release of Liability and, unless prohibited by law, Release of Publicity, within five (5) days of date of issuance.
