Master Official Sweepstakes Rules

Details for an individual Sweepstakes are described below. For each Sweepstakes, the respective Schedule and these master rules ("Master Rules") constitute the official rules ("Official Rules"). In case of any conflict between the Master Rules and the Schedule, the Schedule for the specific Sweepstakes will govern.

ELIGIBILITY. Each Sweepstakes is open to legal residents of the State of Utah who are age 18 or older. Employees of Sponsor, its respective subsidiaries, related and affiliated entities, suppliers, as well as the immediate family (spouse, parents, siblings and children) and household members of all such parties are not eligible. Each entry is subject to verification by Sponsor. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Participation constitutes the full and unconditional agreement to the Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes, by each entrant ("Entrant").

Entrants and their immediate family members who have previously won a prize of either cash, services, or merchandise from Sponsor, its respective subsidiaries, or

HOW TO ENTER. No purchase necessary to enter or win. Only one entry per person during any particular Sweepstakes Period, regardless of entry method or number of accounts. Additional or subsequent or incomplete entries are void. To enter, follow the instructions provided on the applicable Schedule.

SUBMISSION REQUIREMENTS. You must enter via the method or methods provided on the Schedule and, if applicable, must be a member of the associated social media site. Entries must not contain any obscene, profane, lewd, defamatory, or inappropriate matter as determined by Sponsor in its sole discretion. Any entry deemed unsuitable by Sponsor, in its sole discretion, will be disqualified.

WINNER SELECTION AND NOTIFICATION. The number of winners selected in each Sweepstakes will be set forth in the applicable Schedule. Winners will be selected by random drawing from among those eligible entries submitted during the Sweepstakes Period on the date specified in the applicable Schedule. Winners will be notified using the information provided in the entry (via telephone, email, social media account, or other contact information) as determined by Sponsor in its sole discretion. The return of any Prize notification as undeliverable or failure to respond to notices or return any documents in a timely manner, as determined by Sponsor, may result in disqualification and an alternate winner may be chosen.

PRIZES AND VALUES. Each Sweepstakes provides Entrants an opportunity to win a prize or prizes (each, a "Prize"). Each Prize and its approximate retail value are described in the applicable Schedule. Winning a Prize is contingent upon fulfilling all requirements set forth herein. All Prizes are awarded "AS IS" and without warranty of any kind, express or implied (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose). No transfer, substitution, cash redemption or transfer of a Prize is permitted, except at Sponsor's sole and absolute discretion. If a Prize, or any portion thereof, cannot be awarded for any reason, Sponsor reserves the right, at its sole and absolute discretion, to substitute a Prize of equal or greater value. GENERAL RULES. Failure to return these documents within the specified time will result in the prize being forfeited. Sponsor is not responsible for any typographical or other error in the printing of the offer or administration of the Sweepstakes. Sponsor is not responsible for lost, late, misdirected, stolen, illegible, inaccurate, damaged, incomplete, non-delivered or postage-due mail; or for printing, distribution or production errors or for technical, hardware, software, or telephone malfunctions of any kind, lost or unavailable network connections, or failed, incorrect, incomplete, inaccurate, garbled or delayed electronic communications

caused by the user or by any of the equipment or programming associated with or utilized in this Sweepstakes, or by any human, or other error, which may occur in this Sweepstakes. In the event of a dispute regarding the identity of the person submitting an entry, entries will be declared made by owner of the email address, social media account or through other contact information submitted on the entry. Sweepstakes are offered only in the State of Utah and are governed by the laws of the State of Utah. By entering, Entrants irrevocably consent to the sole and exclusive jurisdiction of the courts of the State of Utah located in Salt Lake County for any action, suit or proceeding arising out of or relating to the Sweepstakes.

SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY.

RELEASE AND INDEMNITY. MISCELLANEOUS. The invalidity or unenforceability of any provision of the Official Rules will not affect the validity or enforceability of any other provision. In the event that any provision of the Official Rules is determined to be invalid or otherwise unenforceable or illegal, the other provisions will remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.
