

**REAL MONARCHS TEXT-2-WIN SWEEPSTAKES
OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT
INCREASE YOUR CHANCES OF WINNING.**

ELIGIBILITY: “*Real Monarchs Text-2-Win*” Sweepstakes (the “Sweepstakes”) is open to legal residents who live within a seventy-five (75) mile radius from *Herriman, Utah* (the “Territory”) who are of legal age of majority in the jurisdiction in which they reside (and at least 18 years old) at the time of entry. Game 16: Real Monarchs vs. Colorado Springs. Entry 10/22/21 at 7:00 PM MT and closes on 10/22/2021 at 11:00 PM MT. Game 17: Real Monarchs vs. RGV FC Toros. Entry 10/27/2021 at 7:00 PM MT and closes on 10/27/2021 at 11:00 PM MT. During the Entry Period, there is **one** way to enter. No other method of entry will be accepted. **Limit one (1) entry per person, per family, per e-mail address, per phone number, and per household, as applicable, regardless of method of entry. 1. Text: To enter the Sweepstakes via text message, text *the Keyword mentioned during the game* to the short code **762237**. By sending your text message entry, you agree that you are providing Sponsor express, written consent for you to receive up to [3] text messages using automated technology in response to your entry related to the Sweepstakes and agree to accept all applicable charges associated therewith. You may opt-out of receiving text messages from Sponsor at any time by sending a reply text message with the word “**STOP**”. Text “**HELP**” to the short code above if you would like more information. Your mobile phone must be capable of sending and receiving text messages to participate via this method. Standard text message rates apply. Entry via text messaging may be limited and may not be available through all wireless carriers or on all handsets. See your wireless provider for pricing plan details. All text message entries must be received during the Entry period to be eligible. Proof of text messaging the short code is not considered proof of delivery to or receipt by Sponsor of such Sweepstakes entry. RANDOM DRAWING: The potential winner(s) of the Sweepstakes (each a “Winner” and collectively, the “Winners”) will be selected by random drawing on or about the end of each phase of entries. Phase 5: *Two (2) tickets to each of the Real Monarchs home 2021 playoff matches or one (1) Real Monarchs jersey if there are no home playoff matches*. Approximate Retail Value (“ARV”) of Phase 1 Prize: **\$100**. Total ARV of all Prizes: **\$392**. Transportation to/from stadium is not included and is the sole responsibility of each Winner. Sponsor and the applicable USL Entities reserve the right to remove or deny entry to Winner and/or his/her guest(s) who engage(s) in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person at any game, event or exhibition. Released Parties (as defined below) will not be responsible for weather, Acts of God, acts of terrorism, civil disturbances, work stoppage or any other event that may cause the cancellation or postponement of any USL game, event or exhibition.

NOTIFICATION: Each potential winner must continue to comply with the Official Rules. Winning is contingent upon fulfilling all requirements. *Each* Winner will be notified by e-mail, mail and/or telephone (in the sole discretion of Sponsor and/or the applicable USL Entity, as applicable) by the Sponsor. GENERAL CONDITIONS: Entries generated by a script, macro or other mechanical or automated means or by any means which subvert the entry process will be disqualified. Sponsor and the USL Entities shall have the sole right to disqualify any entrant for violation of these Official Rules or any applicable laws relating to the Sweepstakes, and to resolve all disputes in their sole discretion. Released Parties (i) make no warranty, guaranty or representation of any kind concerning any Prize, and (ii) disclaim any implied warranty. All disputes will be resolved under applicable U.S. laws in the County of Salt Lake, state of Utah without giving effect to choice of law or conflicted law principles (whether of the state of Utah, or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state of New York. Sponsor's failure to enforce any terms of these Official Rules shall not constitute a waiver of that provision.

The Sponsor and the USL Entities, as applicable, reserve the right, in their sole discretion, to cancel or suspend the Sweepstakes for any reason, including should virus, bugs, unauthorized human intervention, or other causes corrupt the administration, security, fairness, integrity or proper operation of the Sweepstakes. In the event of cancellation, Sponsor may elect to identify the Winners and award the Prizes by way of random drawing from among all non-suspect, eligible entries received up to the time of such cancellation.

The “Authorized Account Holder” is defined as the natural person to whom the applicable ISP or other organization (such as a business or educational institution) has assigned the e-mail address for the domain associated with the submitted e-mail address.
