

**CREW 2022 SEASON TICKET RENEWAL SWEEPSTAKES
OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT
INCREASE YOUR CHANCES OF WINNING.**

ELIGIBILITY: The **Crew 2022 Season Ticket Renewal Sweepstakes** (the “Sweepstakes”) is open to legal residents who live within a seventy-five (75) mile radius from Columbus (the “Territory”) who are of legal age of majority in the jurisdiction in which they reside (and at least 18 years old) at the time of entry. Employees, officers, and directors (including immediate family members (spouse, parent, child and sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Crew SC Team Company, LLC (“Club”), Major League Soccer, L.L.C. (“MLS”), and Soccer United Marketing, LLC (“SUM” and collectively with Sponsor, Club and MLS, the “MLS Entities”) and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the Sweepstakes are not eligible to participate or win a prize. The Sweepstakes is subject to all applicable federal, state and local laws, rules and regulations. Void outside Territory, and where prohibited or restricted by law, rule or regulation.

HOW TO ENTER: During the Promotion Period, there are two (2) ways to enter. No other method(s) of entry will be accepted. If you were a Columbus Crew season ticket member during the 2021 MLS season, receive one (1) official “Entry” by making a down payment towards the purchase of your 2022 Columbus Crew season tickets during the Promotion Period. Note that one (1) official Entry shall also be automatically awarded to any 2021 Columbus Crew season ticket member who has remained enrolled in the Auto-Renewing Season Ticket Payment Plan. If you were not a Columbus Crew season ticket member during the 2021 MLS season and are not a season ticket member, receive one (1) Official Entry by hand-printing your complete name, address, city, state and zip code, day & evening telephone number (including area code), date of birth and e-mail address (optional) on a 3”x5” postcard and mailing it in an envelope with proper postage affixed to: **Crew 2022 Season Ticket Renewal Sweepstakes**, c/o Columbus Crew, 1 Black & Gold Blvd., Columbus, OH 43211. Mail-in entries must be postmarked at least five (5) days prior to the applicable Deadline for Entries to be to be eligible. Any postcard(s) submitted must be legible. Incomplete entries are void. Sponsor may use e-mail addresses provided via the Mail-in entry method (as applicable) for prize notification purposes only; however, eligibility to participate in the Sweepstakes is not dependent upon entrant’s provision of this information. If

you want to opt-out of having your entry information used for sending you direct marketing unrelated to this Sweepstakes, write “MARKETING OPT-OUT” on the postcard. The decisions of Sponsor are final and binding on all matters relating to this Sweepstakes. Odds of winning depend on the total number of eligible entries received during the Promotion Period.

Sponsor reserves the right to disqualify any entry it deems to be offensive, inappropriate, not in keeping with Sponsor’s image or that is otherwise not in compliance with these Official Rules, in its sole discretion.

By entering the Sweepstakes, entrants agree to assign all right, title, and interest, including copyright rights, in the entry to Sponsor and grant permission for Sponsor, the MLS Entities and their respective designees to publish or publicize all or part of their entry, including but not limited to entrant’s name, likeness and submission, in whole or in part, for advertising, promotional and trade or other purposes in conjunction with this and similar promotions in any and all media now known or hereafter developed, worldwide in perpetuity, without notice or permission and without further compensation, except where prohibited by law.

Winner is fully responsible for any and all applicable federal, state, and local taxes (including income and withholding taxes). All costs and expenses associated with Prize acceptance and use not specified herein as being provided, All Prize details are at Sponsor's sole discretion.

Released Parties are not responsible for lost, interrupted or unavailable network, server, Internet Service Provider (ISP), website, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors or difficulties that may occur in connection with the administration of the Sweepstakes, the processing of entries, the announcement of the Prize or in any Sweepstakes-related materials. Released Parties (i) make no warranty, guaranty or representation of any kind concerning any Prize, and (ii) disclaim any implied warranty. All disputes will be resolved under applicable U.S. laws in the County of New York, state of New York without giving effect to choice of law or conflicted law principles (whether of the state of New York, or any other jurisdiction), which would cause the application

of the laws of any jurisdiction other than the state of New York. Sponsor's failure to enforce any terms of these Official Rules shall not constitute a waiver of that provision.

The Sponsor and the MLS Entities, as applicable, reserve the right, in their sole discretion, to cancel or suspend the Sweepstakes for any reason, including should virus, bugs, unauthorized human intervention, or other causes corrupt the administration, security, fairness, integrity or proper operation of the Sweepstakes.
