

**2022 Harris Teeter Get Matchday Ready Sweepstakes
Official Rules**

NO PURCHASE NECESSARY TO ENTER OR WIN.

1) Eligibility: The Harris Teeter Get Matchday Ready Sweepstakes (hereafter, "Sweepstakes") is open to legal permanent residents of North Carolina or South Carolina who, prior to the date of entry are eighteen (18) years of age or older (hereafter, "Eligible Entrants"). Employees, officers, directors, agents and representatives of DT Soccer, LLC dba Charlotte FC (hereafter, "Sponsor"), Major League Soccer, L.L.C. ("MLS"), Soccer United Marketing, LLC ("SUM" and collectively with Sponsor and MLS, the "MLS Entities"), Harris Teeter, LLC., each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising & promotion agencies, sponsors (hereafter collectively, "Released Parties"), and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife & their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. Void outside of North Carolina, South Carolina, and where prohibited by law. All applicable federal, state & local laws apply.

2) Promotion Period: Sweepstakes starts at 10:00:00 am Eastern Time ("ET") on June 1, 2022 and ends at 11:59:59 pm ET on August 23, 2022 (hereafter, "Promotion Period") and will be divided into twelve (12) entry periods (each, an "Entry Period") as indicated in the chart below. All Entry Periods begin at 12:00:00 AM ET and end at 11:59:59 PM ET except for Entry Period 1, which begins at 10:00:00am Eastern Time ("ET") on June 1, 2022.

3) How to Enter: There are two (2) ways to enter:

(A) During any/all Entry Periods, visit charlottefootballclub.com/harris-teeter-matchday-sweeps and complete and submit the registration form to receive one (1) entry for a maximum of twelve (12) entries throughout the Promotional Period; or,

(B) During any/all Entry Periods, visit <https://events.harristeeter.com/2022-harris-teeter-get-matchday-ready-sweepstakes> and complete and submit the registration form to receive one (1) entry for a maximum of twelve (12) entries throughout the Promotional Period.

Non-winning entries in each Entry Period will not roll over and will not be included in any subsequent Entry Period. **One (1) entry per person per Entry Period will be accepted for a maximum of twelve (12) entries throughout the Promotion Period. Entries received in excess of the stated limitation will be void.** All entries become the exclusive property of the Sponsor and will not be acknowledged or returned. The use of script, macro or automated devices (or any other devices intended to automate or subvert any aspect of entry) to enter the Sweepstakes is prohibited and any entry through such means and any entry that is deemed to be ineligible (at Sponsor's sole discretion and in accordance with these Official Rules) are void. Released Parties are not responsible for late, lost, stolen, incomplete, misdirected, delayed, garbled, inaccurate, destroyed or undelivered entries, entry information or for telephonic, human or computer failures, problems or errors, interruptions in service due to system upgrades, repairs, modifications or other causes, failures or malfunctions of connections, satellite, network, cable, Internet Service Provider (ISP), phones, phone lines or telephone systems, traffic congestion on the internet, technical or mechanical malfunctions, or other malfunctions or errors, whether caused by equipment, programming, human error or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors which may occur in connection with the administration of the Sweepstakes, the processing of entries, emails or the announcement of a prize; or for any injury or damage to entrant's or any other person's computer relating to or resulting from participation in this Sweepstakes, or for printing, typographical, human or other errors appearing in these Official Rules or other Sweepstakes-related materials. Sponsor reserves the right, in its sole discretion, to void any entries of entrants who Sponsor believes have attempted to tamper with or impair the administration, security, fairness or proper play of this Sweepstakes or is in violation of these Official Rules.

4) Winner Selection: On or about each Drawing Date listed above, one (1) potential First Prize winner will be randomly selected from among all entries received during each Entry Period; for a total of twelve (12) potential First Prize winners during the Promotional Period. Two (2) potential Grand Prize winners will be randomly selected from all entries throughout the Promotional Period; one (1) potential Grand Prize winner will be randomly selected on or about 7/14/2022 from all entries received during Entry Periods 1-6 and one

(1) potential Grand prize winner will be randomly selected on or about 8/25/22 from all entries received during Entry Periods 7-12.

Odds of winning a prize depends upon the total number of eligible entries received throughout each Entry Period. Limit one (1) First Prize per person and one (1) Grand Prize per person during the Promotional Period. By entering, entrants agree to be bound by these Official Rules and to the decisions of the Sponsor, which will be final and binding in all respects. The potential winners will be notified by telephone and/or email and may be required to execute and return a Prize Claim form, and/or any other required documentation required by Sponsor within two (2) days of the date of issuance of notification. Non-compliance with the foregoing, with these Official Rules or return of prize notification as non-deliverable may result in disqualification and, at Sponsor's discretion and time permitting, awarding of prize to an alternate winner.

5) Prizes:

(A). Twelve (12) First Prizes:

Each First Prize winner will receive one (1) \$100 Harris Teeter gift card, one (1) Charlotte FC scarf and one (1) Charlotte FC autographed item. ARV: \$300 each prize.

(B). Two (2) Grand Prizes:

(i). One (1) Grand Prize winner randomly selected on or about 7/14/2022 will receive two (2) lower-level tickets to the Charlotte FC home game on July 30, 2022 at Bank of America Stadium.

(ii). One (1) Grand Prize winner randomly selected on or about 8/25/2022 will receive two (2) lower-level tickets to the Charlotte FC home game on September 10, 2022.

In addition, each Grand Prize winner will receive the following: one (1) premium parking pass, two (2) pre-game hospitality passes, two (2) pre-game field passes (subject to MLS and Stadium rules) to their specified game and one (1) prize pack consisting of one (1) Charlotte FC scarf, one (1) Charlotte FC autographed item, other Charlotte FC branded items at Sponsor's discretion and \$100 in Harris Teeter Gift Cards. ARV: \$1,500.
