

Charlotte FC Staycation Sweepstakes

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN.

Eligibility: The Charlotte FC Staycation Sweepstakes (hereafter, "Sweepstakes") is open to legal permanent residents of North Carolina and South Carolina who are twenty-one (21) years of age or older (hereafter, "Eligible Entrants"). Employees, officers, directors, agents and representatives of DT Soccer, LLC dba Charlotte FC (hereafter, "Sponsor"), Major League Soccer, L.L.C. ("MLS"), Soccer United Marketing, LLC ("SUM" and collectively with Sponsor and MLS, the "MLS Entities"), and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, printers and advertising & promotion agencies, and any and all other companies associated prize providers, and any other person or entity associated with the development or administration of this Sweepstakes (hereafter collectively, "Released Parties"), and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife & their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. Void where prohibited by law. All applicable federal, state & local laws apply.

Promotion Period: Sweepstakes starts 2:00:00 pm Eastern Time ("ET") on July 11, 2022 and ends at 11:59:59 pm ET on July 22, 2022 (hereafter, "Promotion Period").

How to Enter: There are two (2) ways to enter:

(a) Each Eligible Entrant who purchases a ticket using the code **UPTOWN** to the July 30, 2022, August 3, 2022 and/or August 6, 2022 Charlotte FC home games (each a "Charlotte FC Home Game"; collectively "Charlotte FC Home Games") at Bank of America Stadium ("Stadium") will automatically receive one (1) entry into the Sweepstakes.

(b) To enter the Sweepstakes without purchasing a ticket to a Charlotte FC Home Game, print your name, address, city, state, zipcode, phone number, email address and the word UPTOWN on a 3.5" by 5" postcard or piece of paper, and mail the entry to Sponsor's address below. Mailed entries must be postmarked between July 11, 2022 and July 22, 2022 and received by July 25, 2022, in order to be included in the random drawing. No mechanically reproduced, photocopied, illegible, incomplete or inaccurate and entries that subvert the entry process are void.

Unless otherwise stated above, entries must be received by 11:59:59 pm ET on July 22, 2022 to be eligible. **Enter as often as you would like; however, entries not to exceed four (4) entries per Charlotte FC Home Game per Eligible Entrant (twelve (12) entries in total).** All entries become the exclusive property of the Sponsor and will not be acknowledged or returned. The use of script, macro or automated devices (or any other devices intended to automate or subvert any aspect of entry) to enter the Sweepstakes is prohibited and any entry through such means and any entry that is deemed to be ineligible (at Sponsor's sole discretion and in accordance with these Official Rules) are void. In the event of a dispute as to the identity of any entrant, such entrant will be deemed, to be the "authorized account holder" of the e-mail address submitted at the time of entry provided he/she is eligible according to these Official Rules. "Authorized account holder" is defined as the natural person who is assigned to the e-mail address by an Internet access provider, online service provider or other organization (e.g., a business, educational institution, etc.) which is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Released Parties are not responsible for late, lost, stolen, incomplete, misdirected, delayed, garbled, inaccurate, destroyed or undelivered entries, entry information or for telephonic, human or computer failures, problems or errors, interruptions in service due to system upgrades, repairs, modifications or other causes, failures or malfunctions of connections, satellite, network, cable, Internet Service Provider (ISP), phones, phone lines or telephone systems, traffic congestion on the internet, technical or mechanical malfunctions, or other malfunctions or errors, whether caused by equipment, programming, human error or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors which may occur in connection with the administration of the Sweepstakes, the processing of entries, emails or the announcement of the prize; or for any injury or damage to entrant's or any other person's computer relating to or resulting from participation in this Sweepstakes, or for printing, typographical, human or other errors appearing in these Official Rules or other Sweepstakes-related materials. Sponsor reserves the right, in its sole discretion, to void any entries of entrants whom Sponsor believes have attempted to tamper with or impair the administration, security,

fairness or proper play of this Sweepstakes or is in violation of these Official Rules.

Winner Selection: The potential winner will be randomly selected from among all entries received throughout the Promotion Period. Drawing will be conducted by Sponsor on or about July 26, 2022. Odds of winning the prize depends upon the total number of eligible entries received throughout the Promotion Period. By entering, entrants agree to be bound by these Official Rules and to the decisions of the Sponsor and judges, which will be final and binding in all respects. The potential winner will be notified by telephone and/or email and may be required to execute and return an Affidavit of Eligibility, Liability, and (where legal) Publicity Release within two (2) days of date of issuance of notification. Non-compliance with the foregoing, with these Official Rules or return of prize notification as non-deliverable may result in disqualification and, at Sponsor's discretion and time permitting, awarding of prize to an alternate winner.

One (1) Grand Prize: The Grand Prize winner will receive lodging accommodations for two (2) persons at a location near the Stadium beginning at 12:00 pm ET on July 30, 2022 and ending 11:00 am ET on August 7, 2022, one (1) Charlotte FC prize pack consisting of two (2) Charlotte FC scarfs, one (1) Charlotte FC replica kit, other Charlotte FC branded items at Sponsor's discretion and \$300 in gift cards to select restaurants in Charlotte, NC. Approximate Retail Value ("ARV"): \$3,500. **TRANSPORTATION AND FOOD AND BEVERAGE (INCLUDEING NON-ALCOHOLIC BEVERAGES) ARE NOT INCLUDED AS PART OF PRIZE AND IS WINNER'S SOLE RESPONSIBILITY.** Prize is awarded "as is" without any warranty or guarantee, either express or implied by Sponsor. All prize details are at Sponsor's sole discretion. Costs and expenses associated with the acceptance and use of the prize not specified herein as being awarded, including, but not limited to, federal, state and local taxes (if any) are winner's sole responsibility. If grand prize winner and guest are unavailable on the dates specified above, the Grand Prize will be forfeited.

Miscellaneous: No transfer, assignment, cash redemption, or substitution of prize is permitted except by Sponsor who reserves the right to substitute the prize (or applicable portion thereof) with one of comparable or greater value, at its sole discretion. Entrants agree, by entering, that 1) Sponsor, the MLS Entities and each of their respective designees may use (unless prohibited by law), entrant's name, city and state of residence, photograph and/or likeness for advertising, trade and/or any other purposes in any media now or hereafter known throughout the world in perpetuity, without further compensation, permission or notification, 2) Sponsor reserves the right to conduct a background check and entry in the Sweepstakes constitutes entrant's permission for Sponsor to conduct such background check, provided that, to the extent additional authorization is necessary under law, entrants shall authorize such check. Sponsor reserves the right (at its sole discretion) to disqualify any entrant based on the results of the background check or failure of the entrant to properly authorize such check, and 3) the Released Parties shall have no liability and will be held harmless by entrant for any claim, action, liability, loss, injury or damage to entrant or any other person or entity, including, without limitation, personal injury or death to entrant or any other person or damage to personal or real property, due in whole or in part, directly or indirectly, by reason of the acceptance, possession, use or misuse of the prize or participation in this Sweepstakes. Sponsor reserves the right, in its sole discretion, to modify, suspend, and/or terminate this Sweepstakes (or portion thereof) for any reason, including should virus, bugs, non-authorized human intervention or other causes corrupt or impair the administration, security, fairness or proper play of the Sweepstakes and, in the case of termination, at its discretion, select the winner(s) from among all eligible non-suspect entries received prior to the event that required such termination. MLS and SUM have not offered or sponsored this Sweepstakes in any way. **CAUTION:** Any attempt to deliberately damage the website or undermine the legitimate operation of this Sweepstakes is a violation of criminal and civil laws and should such an attempt be made, the Sponsor reserves the right to seek any and all remedies available from any such person(s) responsible for the attempt to the fullest extent permitted by law.

Arbitration: Except where prohibited by law, as a condition of participating in this Sweepstakes, entrant agrees that (1) any and all disputes and causes of action arising out of or connected with this Sweepstakes, or the prize awarded, shall be resolved individually, without resort to any form of class or collective action, and exclusively by final and binding arbitration under the rules of the American Arbitration Association and held at a reasonable location within Mecklenburg County, North Carolina; (2) the Federal Arbitration Act shall govern the interpretation, enforcement and all proceedings at such arbitration; and (3) judgment upon such arbitration award may be entered in any court having jurisdiction. Under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental or consequential damages, or any other damages, including attorneys' fees, other than entrant's actual out-of-pocket expenses (i.e., costs associated with participating in this Sweepstakes), and entrant further waives all rights to have damages multiplied or increased.

Choice of Law: All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the substantive laws of the Mecklenburg County, North Carolina, USA.
