## OFFICIAL RULES FOR @MLS or @RealSaltlake SWEEPSTAKES ON SOCIAL MEDIA

Released Parties (as defined below) will not be responsible for Acts of God, acts of terrorism, civil disturbances, work stoppage or any other natural disaster that may cause the cancellation or postponement of any Major League Soccer game, event or exhibition. Major League Soccer game, event and exhibition tickets awarded as Prizes may not be resold or offered for resale. Any such resale may result in disqualification and Prize forfeiture, and may invalidate the license granted by the game ticket(s).
