

Lance Ticket Snack Pack Enter to Win

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN.

1) Eligibility: The Lance Ticket Snack Pack Enter to Win (hereafter, "Sweepstakes") is open to legal permanent residents of North Carolina or South Carolina who are eighteen (18) years of age or older prior to November 28, 2022, (hereafter, "Eligible Entrants"). Employees, officers, directors, agents and representatives of DT Soccer, LLC dba Charlotte FC (hereafter, "Sponsor"), Major League Soccer, L.L.C. Entries must be received by 11:59:59 pm ET by December 12, 2022 to be eligible. **Only one (1) entry per person will be accepted throughout the Promotion Period. Entries received in excess of the stated limitation will be void.** All entries become the exclusive property of the Sponsor and will not be acknowledged or returned. The potential winners will be notified by telephone and/or email and, in Sponsor's sole discretion, may need to execute and return an Address Verification Form within two (2) days of date of issuance of notification. If potential winner forfeits the prize, then the prize will be awarded to an alternative winner. Non-compliance with the foregoing, with these Official Rules or return of prize notification as non-deliverable may result in disqualification and, at Sponsor's discretion and time permitting, awarding of prize to an alternate winner.

The winner will be able to select their preferred matches to attend, but all match tickets will be for a mutually agreed upon date and match with the Club. Seat locations subject to availability and subject to Sponsor's discretion.
