

**WINGSTOP FAN SWEEPSTAKES SERIES
OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE
YOUR CHANCES OF WINNING.**

ELIGIBILITY: Wingstop Fan Sweepstakes Series (the “Sweepstakes”) is open to legal residents who live within a seventy-five (75) mile radius from Carson, California (the “Territory”) and who are of legal age of majority in the jurisdiction in which they reside (and at least 18 years old on the date of entry). Employees, officers, and directors (including immediate family members (spouse, parent, child and sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Anschutz L.A. To enter, entrants must tag two (2) friends in the comments section of one (1) of the posts and follow both @LAGalaxy and @Wingstop. In order to enter the Sweepstakes through Twitter, entrants will need to be a registered user of Twitter. Registration is free and can be done by visiting <http://twitter.com>. Duplicate entries will be disqualified. If you choose to enter via Twitter using your mobile phone, standard data fees may apply. See your wireless provider for pricing and plan details.
3. **Instagram:** During the Entry Period, LA Galaxy will post one (1) Instagram post per week for a total of four (4) Instagram posts during the Entry Period. Entrants must be logged on to

instagram.com/lagalaxy and follow the instructions provided in the post to fully complete and submit an entry. To enter, entrants must tag two (2) friends in the comments section of one (1) of the posts and follow both @LAGalaxy and @Wingstop. In order to enter the Sweepstakes through Instagram, entrants will need to be a registered user of Instagram. Registration is free and can be done by visiting <http://instagram.com>. Duplicate entries will be disqualified. If you choose to enter via Instagram using your mobile phone, standard data fees may apply. See your wireless provider for pricing and plan details.

WINNERS: There will be four (4) potential winners of the Sweepstakes (each a “Winner,” and collectively, the “Winners”) in all. One (1) Winner will be selected by random drawing on each of the four (4) Winner Drawing Dates as set forth above, from among all eligible entries received by the Sponsor by the applicable Entry Period Deadline. The decisions of Sponsor are final and binding on all matters relating to this Sweepstakes. Odds of winning depend on the total number of eligible entries received during the Entry Period.

PRIZES: There will be four (4) prizes available to be awarded (each a “Prize,” and collectively the “Prizes”). Each Winner will receive the following: (a) one (1) LA Galaxy team jersey signed by one or more member of the LA Galaxy as determined by Sponsor in its discretion; and (b) a \$100.00 Wingstop gift card good at participating Wingstop restaurants (gift card restrictions may apply). Approximate Retail Value (“ARV”) of each Prize: \$350.00; total ARV of all Prizes: \$1,400.00.

Winners are fully responsible for any and all applicable federal, state, and local taxes (including income and withholding taxes).
