

## Season Ticket Member PIF Season Ticket Sweepstakes

### Official Rules

**1) Eligibility:** The **Season Ticket Member PIF Season Ticket Sweepstakes** (hereafter, "Sweepstakes") is open to Charlotte Football Club Season Ticket members who, prior August 26, 2023, are eighteen (18) years of age or older (hereafter, "Eligible Entrants"). Employees, officers, directors, agents and representatives of DT Soccer, LLC dba Charlotte FC (hereafter, "Sponsor"), and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, printers and advertising & promotion agencies, and any and all other companies associated prize providers, and any other person or entity associated with the development or administration of this Sweepstakes (hereafter collectively, "Released Parties"), and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife & their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. To receive one (1) entry into the Sweepstakes, the full 2024 season payment must successfully process on October 17, 2023 date.

**To ENTER BY MAIL WITHOUT PURCHASE OR OBLIGATION:** Hand-print your complete name, street address, city, state, Zip code, and daytime and evening telephone numbers (including area code), and valid email address, on a plain piece of 3"x5" paper, and mail in a business-size (#10) envelope with sufficient postage affixed, to Charlotte FC, 800 South Mint Street, Charlotte, North Carolina 28202. Mailed entries must be postmarked between September 14, 2023, and October 17, 2023 to be included in the random drawing. Entries that are mechanically reproduced, copied, illegible, incomplete, or inaccurate, and entries by any means which subvert the entry process are void. Entries become the property of the Sponsor and will not be acknowledged or returned.
