

TRAVEL THE GALAXY WITH FIJI AIRWAYS SWEEPSTAKES

OFFICIAL RULES

**NO PURCHASE OR PAYMENT REQUIRED TO ENTER OR WIN.
SWEEPSTAKES VOID WHERE PROHIBITED.**

The details of the Prize and how to enter the Sweepstakes are contained in these Official Rules.

ELIGIBILITY. TRAVEL THE GALAXY WITH FIJI AIRWAYS SWEEPSTAKES (the “Sweepstakes”) is open to legal U.S. residents, who are at least 18 years of age at the time of entry, and who live within a seventy-five (75) mile radius from the City of Carson, California. Employees, officers and directors (including immediate family members (spouse, parent, child and sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Anschutz L.A. Soccer, Inc., a/k/a LA Galaxy (the “Sponsor”), Anschutz Entertainment Group, Inc., Air Pacific Limited, trading as Fiji Airways (“Fiji Airways”), Anschutz Southern California Sports Complex, LLC, Major League Soccer, L.L.C. (“MLS”), Soccer United Marketing, LLC (“SUM”), Pro Soccer Development, LP (“MLSNP”), and Player Development, LLC (“PDEV,” and together with MLS, SUM, and MLSNP, the “MLS Entities”), any Sweepstakes sponsors, and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associate with the Sweepstakes are not eligible to participate or win a prize. The Sweepstakes is subject to all applicable federal, state, and local laws, rules and regulations. Void outside California and where prohibited or restricted by law, rule or regulation.

TIMING. The Sweepstakes begins at 12:00 p.m. Pacific Daylight Time (“PDT”) on October 16, 2023 and ends at 11:59 a.m. PDT on October 27, 2023 (“Promotion Period”). The Sweepstakes consists of two (2) random Drawings as defined below, and each Drawing will have its own Drawing Deadline and Drawing Date. See below for each Drawing Deadline and corresponding Drawing Date.

TO ENTER. During the Promotion Period, there are four (4) ways to enter: Facebook, Twitter, Instagram, or TikTok. No other methods of entry will be accepted. Regardless of method of entry, there is a limit of one (1) entry per person, per e-mail address, per social media account and per household during the Promotion Period. Multiple entries received from any person or e-mail address or household in excess of the stated limitation will be void. The clock of the Sponsor will be the official timekeeper for this Sweepstakes. Entries received prior to or after the Promotion Period are disqualified. During the Promotion Period, Sponsor will post content of LA Galaxy team doing their best airplane celebrations. Entrants will be instructed to share a photo or video themselves doing an airplane celebration using one of the following methods:

- **Twitter Method:** To enter the Sweepstakes via Twitter, entrant must post their original photo or video on their Twitter social media account, tag @lagalaxy and @fijiairways, and use the hashtag #TravelTheGalaxywithFijiAirways to enter. If you do not already have a Twitter account, you may sign-up for free at www.twitter.com;
- **Instagram Method:** To enter the Sweepstakes via Instagram, entrant must post their original photo or video on their Instagram social media account, tag @lagalaxy and @fijiairways, and use the hashtag #TravelTheGalaxywithFijiAirways to enter. If you do not already have an Instagram account, you may sign-up for free at www.instagram.com;

or

- **TikTok Method:** To enter the Sweepstakes via TikTok, entrant must post their original photo or video on their TikTok social media account, tag @lagalaxy and @fijiairways, and use the hashtag #TravelTheGalaxywithFijiAirways to enter. If you do not already have a TikTok account, you may sign up for free at www.tiktok.com.

Follow all instructions of the Sweepstakes provided by Sponsor. Entrant must provide all required information in order to be eligible. By entering the Sweepstakes via Facebook, Twitter, Instagram, or TikTok as directed above, you will receive one (1) entry in the Sweepstakes. If you choose to enter via Facebook, Twitter, Instagram, or TikTok using your mobile phone, standard data fees may apply. See your wireless provider for pricing plan details. Your Facebook, Twitter, Instagram, or TikTok account may be cancelled at any time.

This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with, Facebook, Twitter, Instagram, or TikTok. You are providing your information to Sponsor and not to Facebook, Twitter, Instagram, or TikTok.

Failure to follow any instructions provided may result in disqualification.

AGREEMENT TO OFFICIAL RULES. Participation in the Sweepstakes constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and MLS' Privacy Policy and Terms of Service and to be contacted by telephone and/or email.

PUBLICATION AND ASSIGNMENT OF RIGHTS TO PHOTO OR VIDEO SUBMISSION: By entering the Sweepstakes, entrants agree that their photo or video submission ("Submission") is an original photograph or video and that entrant owns all right, title and interest in as of the date of the Submission. All non-winning eligible entries from one Drawing will be eligible for any subsequent Drawing.

SELECTION OF POTENTIAL WINNERS. Two (2) winners will be selected in all as follows: one (1) First Place Winner ("First Place Winner") and one (1) Grand Prize Winner ("Grand Prize Winner") (hereinafter, First Place Winner and Grand Prize Winner, also each referred as a "Winner" and collectively, as the "Winners"). Winners will be selected by random drawing on or around each of the two (2) Drawing Dates as set forth above, from among all eligible entries received by the Sponsor by the applicable Drawing Deadline. Potential winners will be notified via phone or email by Sponsor (in its sole determination). Sponsor's decisions as to all matters related to administration of the Sweepstakes and selection of the Winners is final. First Place Winner and guest must travel on the same itinerary. First Place Winner is responsible for booking all travel arrangements. Grand Prize: Grand Prize Winner will receive: (i) two (2) round trip economy class airline tickets (for use by Winner and one (1) guest) on Fiji Airways from LAX to FIJI (NAN) and (ii) three (3) nights hotel accommodations (luxury king room/double occupancy on bed and breakfast basis) at Sofitel Fiji Resort & Spa on Beachfront, Denarau Island, Fiji (collectively, the "Grand Prize"). Approximate Retail Value ("ARV") of Grand Prize: \$5,500.00. Grand Prize Winner's guest must be 18 years of age or older. Grand Prize Winner and guest must travel on the same itinerary. Grand Prize Winner is responsible for booking all travel arrangements. Grand Prize does not include: any ground transportation, meals, beverages, gratuities, or any other expenses of a personal nature not otherwise set forth above.

Hereinafter, First Place Prize and Grand Prize also each referred to as a "Prize" and collectively, as the "Prizes". ARV of all Prizes: \$9,000.00.

PRIZE RESTRICTIONS: Prizes must be redeemed within twelve (12) months from the Drawing Date. All bookings are subject to Fiji Airways' condition of carriage in effect at the time of booking. Economy class airline tickets cannot be upgraded to a higher fare class by paying the fare difference.
