# WASHINGTON CONSUMER HEALTH DATA PRIVACY POLICY

Updated: January 9, 2024

#### INTRODUCTION

At Seattle Sounders FC ("SFC"), we are committed to safeguarding your information and respecting your privacy in accordance with applicable laws. This Consumer Health Data Privacy Policy ("Policy") applies to personal data defined as "consumer health data" subject to the Washington State My Health My Data Act ("MHMDA") and outlines what data we collect, the sources from which we collect or may share data, the purpose for collecting such data, and how to exercise your rights. We encourage you to read this Policy carefully to understand our practices and how they affect you.

## **CONSUMER HEALTH DATA WE COLLECT**

Under the MHMDA, SFC is required to disclose the categories of consumer health data that may be collected from you. Examples of health data SFC may collect include:

- <u>Individual health conditions, treatment, diseases, or diagnoses.</u> This may include physical characteristics or descriptions, health history, tests, and other medical information, policy and other health insurance information, or sex (including gender or other related medical conditions);
- Health-related surgeries or procedures, diagnostic testing, and treatment. This may include, for example, data concerning surgical outcomes and post-operative care information, results of medical tests and diagnostic procedures, imaging data such as X-rays, MRIs, CT scans, or information about prescribed medications;
- <u>Biometric data.</u> Biometric data may include data generated from measurements or technological processing of individual's physiological, biological, or behavioral characteristics and that identifies a consumer, including, but not limited to physical patterns, sleep, health, or exercise data; and
- <u>Genetic data.</u> Genetic data is any data that concerns a consumer's genetic characteristics, including, but not limited to: (i) raw sequence data that result from the sequencing of a consumer's DNA or a portion of the extracted DNA; (b) genotypic and phenotypic information that results from analyzing the raw sequence data; and (c) self-reported health data that a consumer submits to Seattle Sounder FC and that is analyzed in connection with consumer's raw sequence data.

## **SOURCES OF COLLECTED CONSUMER HEALTH DATA**

We collect health data with your consent, directly from you through athletic performance and physical engagement with SFC and in accordance with Major League Soccer ("MLS") League Rules (as defined by MLS) and its collective bargaining framework. We may also collect information about you from other

sources like medical providers, which we may combine with other information we have collected from you.

#### PURPOSE FOR COLLECTING AND USING CONSUMER HEALTH DATA

At SFC, we collect and use health data:

- As directed by you and through the League Rules;
- To monitor and measure athlete performance and activity to ensure optimal performance;
- To evaluate athlete medical and health activity; and
- To comply with applicable laws and MLS League Rules and requirements.

#### SHARING CONSUMER HEALTH DATA

The Seattle Sounders FC may share any of the collected categories of health data for purposes as described above. We will only share your consumer health data with internal personnel, League representatives as required by MLS League Rules, and government authorities as necessary to comply with applicable law. For example, we will share health data with medical personnel where you were injured during a match or in-season activity such as training or camp.

## THIRD PARTIES WITH WHICH WE SHARE CONSUMER HEALTH DATA

Health data we collect from you may be shared with internal parties, including:

- Medical personnel;
- Performance or training coaches; and
- Administrative personnel.

## **HOW TO EXERCISE YOUR RIGHTS**

MHMDA provides certain rights with respect to consumer health data, including the right to access, delete, or withdraw consent relating to your consumer health data, subject to certain exceptions. You may exercise any of your rights by contacting us directly using the contact details found in this Policy. The written request should include sufficient information to verify your identity and specify the right you wish to exercise. For any questions or assistance, you may also reach out using the contact information below.

If your request to exercise a right under the MHMDA is denied, you may appeal that decision by contacting our legal team. If your appeal is unsuccessful, you can raise a concern or lodge a complaint with the Washington State Attorney General at <a href="https://www.atg.wa.gov/file-complaint">www.atg.wa.gov/file-complaint</a>.
