## **OFFICIAL RULES**

## NO PURCHASE NECESSARY TO ENTER OR WIN

**ELIGIBILITY:** The Texas Lottery "Luck Happens" Enter-to-Win Giveaway ("<u>Giveaway</u>") is open to legal residents who live within a seventy-five (75) mile radius of Q2 Stadium ("<u>Stadium</u>") in Austin, Texas, plus to the extent not included in the foregoing, the geographic area included within the corporate limits of the City of San Antonio, Texas and the City of San Marcos, Texas ("<u>Territory</u>") and who are at least eighteen (18) years old at the time of entry. Employees, officers, and directors (including immediate family members (spouse, parent, child, and sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Austin TeamCo LLC d/b/a Austin FC ("<u>Austin FC</u>" or "<u>Sponsor</u>"), Major League Soccer, L.L.C. ("<u>MLS</u>"), Soccer United Marketing, LLC ("<u>SUM</u>"), Pro Soccer Development, LP ("<u>MLSNP</u>"), and Player Development, LLC ("<u>PDEV</u>" and together with MLS, SUM, and MLSNP, collectively, the "<u>MLS Entities</u>"), IGT Global Solutions Corporation ("<u>IGT</u>"), Texas Lottery Commission ("<u>Texas Lottery</u>"), and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers, and advertising and promotion agencies, and any and all other companies associated with the Giveaway are not eligible to participate or win a Prize. This Giveaway is in no way sponsored, endorsed, or administered by or associated with Facebook, X (formerly known as Twitter), or Instagram. The Giveaway is subject to all applicable federal, state, and local laws, rules, and regulations. Void outside Territory and where prohibited or restricted by law, rule, or regulation.

PRIZE: For each 2024 MLS regular-season Austin FC home match, one (1) Winner will receive two (2) Austin Telco Terrace admission tickets total (i.e., one (1) for the Winner and one (1) for a guest) to attend that specific match at the Stadium. Each such admission ticket will include access to the Austin Telco Terrace, which is the 300-level concourse on the west side of the Stadium, with access provided a minimum of sixty (60) minutes before the opening whistle of the match, plus two (2) Austin FC-branded items (e.g., t-shirt, scarf) and one (1) \$25 credit foodand-beverage credit valid at any concession stand in the Stadium during the event for the purchase of food and/or non-alcoholic beverages (for clarity, the credit expires at the conclusion of the event and does not carry over to subsequent events).

A total of seventeen (17) Prizes are available to be awarded in connection with the following 2024 Austin FC matches: February 24 vs. Minnesota United FC, March 9 vs. St. Louis City SC, March 16 vs. Philadelphia Union, March 30 vs. FC Dallas, April 6 vs. San Jose Earthquakes, April 27 vs. LA Galaxy, May 15 vs. Houston Dynamo FC, May 18 vs. Sporting KC, May 29 vs. Portland Timbers, June 19 vs. LAFC, July 6 vs. NYCFC, July 13 vs. Seattle Sounders FC, July 20 vs. Charlotte FC, August 31 vs. Vancouver Whitecaps FC, September 21 vs. Houston Dynamo FC, September 28 vs. Real Salt Lake, and October 19 vs. Colorado Rapids. The Approximate Retail Value of each Prize is \$220. The Winner is fully responsible for any and all applicable federal, state, and local taxes (including income and withholding taxes). All costs and expenses associated with Prize acceptance and use not specified herein, in addition to all Prize details, are at Sponsor's sole discretion.

**HOW TO ENTER**: The entry period for the Giveaway begins on **February 12, 2024 at 10:00 am CT** and ends on **October 16, 2024 at 11:59 pm CT** ("Entry Period"). During the Entry Period, any entrant who satisfies the eligibility requirements set forth herein will be eligible to enter the Giveaway to win the Prize by completing the following actions:

Enter to win by clicking on the Giveaway link that will be provided on Austin FC's official club website (austinfc.com) and, from time to time during the Entry Period, on Austin FC's X, Facebook,

and/or Instagram channels and then completing the online submission form, including confirming eligibility, agreeing to these rules, and providing the entrant's first name, last name, date of birth, phone number, and email address. Other than a previous Winner of a Prize, all entrants who enter the Giveaway during the Entry Period remain eligible to win a subsequent Prize during the Giveaway. This is the only way to enter the Giveaway. No other method of entry will be accepted.

**RANDOM DRAWING**: Two (2) days before each remaining 2024 MLS regular-season Austin FC home match, a potential winner of the Giveaway for that particular match ("<u>Winner</u>") will be selected by random drawing by Sponsor from among all eligible entries received by Sponsor during the Entry Period. The decision of Sponsor is final and binding on all matters relating to this Giveaway. Odds of winning depend on the total number of eligible entries received during the Entry Period at the time of each random drawing.

**NOTIFICATION:** Sponsor will notify each Winner by phone and/or email. In the event that any Winner does not respond to any such notification within one (1) day of the date of issuance, a disqualification will result, the Prize will be forfeited and an alternate Winner will be chosen from among all remaining eligible entries. Each Winner shall confirm eligibility, agree to these rules, and confirm Winner's first name, last name, phone number, and email address. Each Winner also may be required to submit Winner's valid social security number (if applicable) and/or other identification to Sponsor and may be required to execute, have notarized, and return an Affidavit of Eligibility and Release of Liability and, unless prohibited by law, Release of Publicity, within two (2) days of date of issuance.
