

## SOUNDERS FC TRAINING FACILITY VISITOR POLICY

Visitors are an integral part of our community, and we expect them to contribute positively to the environment. To create a safe, enjoyable, and respectful environment for all visitors, we have established this Facility Visitor Policy (the “Policy”). This Policy applies to all persons who, at any time, are at, on, or within the Facility, including guests, visitors, contractors, and vendors. Without limitation of any other policies, procedures, or contract terms which may be applicable, all such persons are required to adhere to the terms of this Policy.

### I. VISITOR CODE OF CONDUCT

- a. General Conduct. Visitors must engage in respectful and courteous behavior towards employees, other visitors, and the facilities. Harassment, discrimination, or offensive behavior will not be tolerated. Visitors should avoid any behavior that may disrupt the enjoyment of others. This includes excessive noise, public intoxication, or engaging in activities that may pose a danger. All visitors must use appropriate and respectful language. Profanity, hate speech, or any form of verbal abuse or obscene/offensive gestures is unacceptable. Visitors may not engage in fighting, taunting, challenging others to fight, throwing objects, or other behavior deemed detrimental to the experience of other visitors. Those who engage in any of these actions will immediately be removed from the Facility without refund or reimbursement, if applicable, and may be referred to law enforcement. All guests are encouraged to take ownership in the enjoyment of their event experience by reporting inappropriate or unlawful behavior to Facility personnel.
- b. Safety and Security. Visitors are responsible for their personal belongings. The Seattle Sounders FC is not liable for any loss or stolen items while on, at, or within the Facility. Visitors should familiarize themselves with emergency exits, evacuations routes, and follow instructions from staff during emergency situations. Visitors shall comply with requests from Facility personnel regarding operational and emergency procedures as well as with all posted signs and placards. Visitors may be required to participate in a security check upon entry into the Facility. Failure to comply may result in being denied entry.
- c. Smoking and Vaping. Visitors shall not smoke or use e-cigarettes or vaporizers while in the Facility. Smoking and vaping are only permitted in designated areas outside of the Facility. Dispose of cigarette butts and vaping materials properly.
- d. Facility's Alcohol Policy. Visitors who choose to consume alcohol must do so in a legal and responsible manner that is consistent with [Lumen Field Alcohol and ID Policies](#). No outside alcohol will be allowed on the premises or in the Facility.

### II. VISITOR PROCESS & PROCEDURE

- a. Facility Parking. Visitors will have designated visitor parking in the south parking lot. Please look and follow the clearly marked areas designated for visitor parking. Visitors should be cautious of any parking restrictions, such as reserved spaces, no-parking zones, or time limits. Violations of parking rules may result in towing. If you require accessible parking, please follow signage, or ask parking attendants for assistance. Overnight parking is not permitted for visitors.
- b. Entry and Check-In. Upon arrival, visitors must adhere to any security measures prior to entry that may include, but are not limited to, bag searches, magnetometer or wandings. All visitors are required to check-in upon arrival at the designated visitor entrance. Upon check-in, all visitors must agree to Facility policies, obtain visitor badges or credentials, where applicable, and complete any other check-in requirements associated with events at the Facility. Once your visit is complete, you must check-out either within our visitor management system or at the reception desk.

c. Facility Access. Visitors may only access areas that they have expressly been granted access to. Visitors may not attempt to access areas within or outside of the Facility that visitors do not have permissions to access. Visitors may only use their designated entrances and exits when entering and leaving the Facility. When required, escorts will be provided to accompany visitors through restricted areas. This ensures the safety and security of both visitors and the facilities. At no time shall any visitor escort or otherwise allow any person to enter the Facility or secured area without a valid ticket, credential, or visitor's pass. Violation of this policy may result in disciplinary action at Seattle Sounders FC's sole discretion.

### III. VISITOR PERSONALITY RELEASE AND COMMUNICATION CONSENT.

By entering the Facility, you hereby grant the Facility and Seattle Sounders FC an irrevocable, perpetual right and license to use photographs, videos, audio recordings, name, quotes, testimonials, or any other media or editorial captured during your visit for publicity, promotional, marketing, and social media purposes. You understand and agree that these materials may be used in various publications, advertisements, or other media formats, including online and offline platforms without any compensation or further notification. You release the Facility and Seattle Sounders FC, its agents, employees, owners, directors, officers, and representatives from any claims or liability arising out of the use of such materials for any purpose. Additionally, by providing your contact information, you consent to receive commercial communications from Seattle Sounders FC via email, SMS, or other electronic means. These communications may include newsletters, promotional offers, product announcements, and other marketing materials. If such messages are provided via SMS, you acknowledge that standard message and data rates may apply. You understand that you may opt-out of receiving commercial communications at any time by following the opt-out instructions provided or contacting the Facility directly. Your consent is voluntary and opting out of commercial communications will not affect your ability to receive transactional or service-related communications, including Facility updates such as emergency notifications. Data collected by Sounders FC is processed in accordance with the [MLS Privacy Policy](#).

### IV. VIOLATION OF VISITOR POLICY

Violation of this Policy or of any other Facility policy, procedure, or directive from Facility personnel may result in any one or multiple of the following: (i) denial of entry or re-entry into the Facility; (ii) verbal or written warning from Facility security personnel; (iii) ejection from the Facility without refund, if applicable; (iv) revocation of future Facility access privileges and/or prevention from attending future event; (v) citation, summons, or arrest (as determined by law enforcement officials); or (vi) any and all other applicable civil or criminal penalties (as determined by law enforcement officials).

### V. VISITOR RELEASE AND WAIVER

By voluntarily entering the Facility or participating in activities within the premises, you understand and accept that there are inherent risks associated with your visit and participation, including but not limited to: (i) physical injury or harm due to slips, trips, falls, collisions, or other accidents; (ii) exposure to potential hazards, such as uneven terrain, equipment, or environmental conditions; (iii) risks associated with engaging in physical activities or using facilities on the premises; and (iv) possible exposure to illnesses or communicable diseases.

You understand that the Facility has taken reasonable measures to ensure your safety, but it is impossible to eliminate all risks entirely. By entering the Facility and participating in activities or events, you knowingly and voluntarily assume all such risks, whether known or unknown, foreseeable or unforeseeable. You hereby release, waive, discharge, and covenant not to sue the

Facility or Seattle Sounders FC its owners, employees, agents, and representatives from any and all liability, claims, demands, actions, or rights of action which may arise out of or in connection with your visit and participation.

I affirm that I am of legal age and competent to acknowledge this Facility Visitor Policy. I have read and understand this document in its entirety, and I voluntarily agree to its terms.
