AFTER HOLDING FOCUS GROUPS WITH THE STUDENTS MLCF LEARNED THAT THEY FEEL GOOD WHEN SOMEONE IMPORTANT LIKE AN FC CINCINNATI PLAYER RECOGNIZE THEM FOR THEIR ACCOMPLISHMENTS.
