**ELIGIBILITY: THE HUNTSVILLE CITY FC TEAM STORE GIVEAWAY** (the “Sweepstakes”) is open to legal United States residents who live within a twenty-five (25) mile radius from **HUNTSVILLE, ALABAMA** (the “Territory”) who are at least eighteen (18) years of age and the legal age of majority in the jurisdiction in which they reside at the time of entry. responsible for any claims arising from an entry specifically including, but not limited to, claims for intellectual property infringement and privacy rights violations, as well as violations of the respective social media site's terms and conditions.

In the event of a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible.
